Unidentified vehicles will be towed at owner's expense!

Canopies are allowed and advised. A word of caution - the month of June can be breezy in Corona. Please bring weights or milk cartons to fill with water for weights for canopies, easels, etc. The event is on asphalt. Stakes are not allowed. Thanks!

The space contracted for is to be used solely for the name that appears on this contract and it is agreed that no portion will be sublet or assigned without the written consent of the Corona Heritage Foundation. In the event that the applicant fails to occupy or use their space, all prepaid rents and the right to the space shall be forfeited.

No signs, banners, decorations, or special displays will be permitted in aisles or outside display spaces. *No sales or solicitations can be made outside of the display space.* Music or other broadcasts must not interfere with event entertainment and announcements.
